

This casebook was required for a class and I did like it in how comprehensive it was with the

creation of cases included in it, but honestly, if you are from a background where you have faced any sort of adversity or oppression, or work with those who face those things, you won't need to try and apply these cases to what you are learning. Good for those who are just starting out and just beginning to think in clinical language and framing of issues in a clinical manner.

This was one of the worst texts I was assigned in my MSW career, and should have been one of the most important. It was lazily and insufficiently updated for the DSM5. It is extraordinarily short for trying to explain the entire DSM. It clumps large amounts of disorders into very short chapters with not nearly enough information. The cases are generic, and expect you to make leaps in order to make a diagnosis which you should never make as a clinician.

I LOVE this book. It's well organized, easy to read, and includes tools for assessment, biopsychosocial influences, risk and protective factors, interventions, medications, and case studies. I originally rented, but just had to go back and buy it. I'll definitely be referring to this book in the future.

What I most love about this books formatting is that each chapter is regarding one and/or two mental health disorders. This helped me a lot by getting organized and also by understanding the material better,
