

PREFACE Ethnic unrest and tension are prevalent in the contemporary world. Newspapers and television news are rife with stories about ethnic violence among the peoples of the former Soviet Union and Eastern Europe, Africa, Sri Lanka, India, Ireland, the Middle East, and the United States. Thus, as globalization rapidly expands and both undermines and strengthens ethnic and national identities, an understanding of race and of ethnicity issues becomes more pertinent. Although this book is thoroughly informative, it is awful as a textbook for a college class. Or any class for that matter. It is written like a regular book, making it very difficult to find specific information if needed. There is no glossary or index, making it even more difficult. There are no keywords either. I wouldn't recommend this as a textbook, but as a regular book if you just want to learn about race and ethnicity on your own. I considered myself relatively informed about race and ethnicity, but there are a lot of things in this book that are very interesting and go deeper into the topic.
