

After the seemingly never-ending media coverage of pregnant Laci Peterson's Christmas Eve 2002 disappearance and husband Scott's subsequent arrest, trial, conviction and death-penalty sentence for her murder, it's hard to believe anything about this notorious case could still be "untold." But Court TV anchor Crier and co-author Thompson's encyclopedic tome includes never-before-released transcripts of conversations between Scott and others (which don't significantly impact one's understanding of the case, however) and a 38-page appendix of photos, documents and other police evidence. Although much of the information in this book has been reported previously or revealed at trial, anyone looking for a comprehensive overview of the case will find it here. The authors chart not only the police investigation and trial but the personal and

family history of Scott and Laci. A more balanced examination of the case is all that's missing to make this book really stand out. Up front, Crier states that since the first days of the case, she felt certain that Scott was a sociopath responsible for his wife's disappearance, and throughout the book, she demonstrates how and why. Given Scott's behavior in the weeks prior to and immediately after Laci's disappearance, not to mention all the lies he told to police, family and friends, she's not exactly going out on a limb. Although few people would doubt Scott's guilt, the whole book is very pro-police-it's even dedicated "To all those who protect and serve." Had the authors started from a presumption of innocence and turned a critical eye on the investigation, which yielded more circumstantial than solid forensic evidence, the book would have been more compelling, but its thoroughness will draw many readers nonetheless. 12 pages of color photos. There were so many misspellings and grammatical errors. How unprofessional! Ridiculous. How did this book go to print like this?

Good book about a heartbreaking story. Would have been 4 stars, but there are some very distracting typos on the kindle version. Lots of unnecessary hyphens, then with 30% to go, Laci's name is often replaced with LCI instead. Distracting and difficult to get through only because of the typos.

The number of typos and misprints in the Kindle version of this is distracting. Every page contains several, which makes the reading far too cumbersome and confusing in some cases. Coupled with a subpar writing style, this is one to pass on.

I've read a couple of books about Scott Peterson before, but hadn't caught this one. I thought it did a great job of outlining the case against him and also listed things I hadn't read about before.HOWEVER - there were several (I quit counting) typographical errors that I felt could have been caught by a high school proofreader. More than 20 times, the name "Laci" was changed to "LCI" and you just had to figure that one out yourself. Several names were misspelled.I just expected better grammar/proofreading. However, the book is solid good reading so if you can look past the typos on the Kindle version, I would recommend reading it.

This review is for the Kindle version. This is a well written account of the sad sad story. I give the writing 5 stars. Get this book! But get a paperback not the electronic version. Honestly, there are so many typos and other formatting errors that I had difficulity staying "in" the book. While I have run into other publications with these types of errors, this book has so many I wonder if this was the first time for the person who created the Kindle version. I had been hoping that the error count would lessen as more people purchased books in the Kindle format, but I am at the point now that I will have to think twice before I do that "one click" and instead pony up the extra dollor or so and wait for the paperback to arrive. So the book gets a five star rating, but the Kindle formatting gets no stars.
