

When Deng Xiaoping launched China on the path to economic reform in the late 1970s, he vowed to build ââ ¬Å"socialism with Chinese characteristics.â⠬• More than three decades later, Chinaââ ¬â,,¢s efforts to modernize have yielded something very different from the working peopleââ ¬â,,¢s paradise Deng envisioned: an incipient kleptocracy, characterized by endemic corruption, soaring income inequality, and growing social tensions. Mustering compelling evidence from over two hundred corruption cases involving government and law enforcement officials, private businessmen, and organized crime members, Minxin Pei shows how collusion among elites has spawned an illicit market for power inside the party-state, in which bribes and official appointments are surreptitiously but routinely traded. This system of crony capitalism has created a legacy of criminality and entrenched privilege that will make any movement toward democracy difficult and disorderly. Rejecting conventional platitudes about the resilience of Chinese Communist Party rule, Pei gathers unambiguous evidence that beneath ChinaA¢â ¬â,,¢s facade of ever-expanding prosperity and power lies a Leninist state in an advanced stage of decay.

This book is full of statistical analysis based on convicted persons at all levels of government. Its is both tedious and fascinating. The amount of corruption and the various motives across the Chinese society is well documented. Its difficult to read as the Chinese names are not easy to remember, but that is simply my lack of exposure to their language. What is fascinating is the many motives and the complexity of the schemes involved to maintain the corruption, with the end goals of power and money.

Interesting book. There is a lot of repetition of ideas which can make the chapters a bit difficult to get through. The relationship between collusion and corrupting is very interesting. The only complaint is that the author's assertion that his kind of corruption didn't start until the mid-90's has some faulty premises. Using word searches for concepts that didn't really exists on a new technology is not going to yield many results. So using that as a benchmark to try to determine the rise of corruption might not be a good place to start. Also it would have been a bit more interesting to add some history to the context. It is not as if China and bureaucracy are a new team.

Very hard to follow especially with the names. The author assumes you know about the most of the cases he/she analyses. The analysis is really sound and useful but only for the veterans in chinese

coruption campaigns. If you are only vaguelly familiar with these cases it will be dificult to follow.

Pei Minxun looks at corruption in China in a very detailed manner. From this book, corruption looks like an entrenched part of the system. Given also recent discoveries about the corrupt relatives of the highest leaders in the country, it looks like corruption is a feature of China's governance. I only wished there was a more explicit framework - otherwise this is a very good book on corruption in China.

Well written: clear, concise and quite an exhaustive review/expose. One wonders if the Chinese Communist Party's hold on the country's governance will start crumbling sooner rather than later, with not easily foreseeable consequences for the rest of the world.

I like it because it gives a rational explanation of what is happening in China and what President Xi is up against. Will he change the system to stop the continuing corruption?
